Registration

- Breeder/Seller certifies that this puppy was bred in accordance with the ANKC registration requirement for purebred dogs.
- Breeder/Seller has made application to DogsNSW for Litter Registration and individual papers for your Puppy will be issued direct to you, or supplied with the Puppy if already obtained. Papers will be provided within 45 days of sale (dependent upon DogsNSW processing times).
- Buyer agrees that if, at any time during the life of Puppy, you are unable to keep Puppy then **ownership of Puppy reverts to Breeder/Seller (Kortmar Shiba Inu) FOR NO COST** and they will make the necessary arrangements to find a suitable new home.

Main Registration

- Puppy is being sold on MAIN REGISTRATION.
- On MAIN REGISTRATION, Puppy is able to compete in Obedience, Agility and the Conformation Show Ring.
- On MAIN REGISTRATION, Puppy is able to have offspring registered with the ANKC or relevant State/Territory body providing other requirements as a Breeder are met.
- On MAIN REGISTRATION, Puppy is intended to be shown in the conformation Show Ring and Buyer has made an undertaking to Breeder/Seller that they will do the necessary training and shows to achieve Puppy's Australian Championship status.
- The Buyer agrees to attain Australian Championship status for Puppy by three (3) years of age and if this is not achieved, Buyer agrees to desex Puppy and NOT breed from them. Buyer will provide Breeder/Seller with proof of neuter/desexing.
- Breeder/Seller guarantees Puppy against mandatory conformation show ring requirements - having a suitable bite and for males, two normally descended testicles. A replacement show potential puppy will be supplied if Puppy is returned to the Breeder/Seller for rehoming in this instance.
- Buyer agrees to achieve Australian Championship status for Puppy BEFORE breeding.
- Buyer agrees to undertake health checks (Hips, Elbows and Patella's mandatory, Eyes optional) and have satisfactory outcomes (Hips no more than 10 total score (both hips), Elbows 0/0 and Patella's no more than 1/1) before breeding.
- Buyer agrees to provide show results to Breeder/Seller or enter those directly into the Dogzonline pointscore to be credited towards the Kortmar breeder tally.

Health Guarantee

- Breeder/Seller certifies that Puppy is, to the best of our knowledge, healthy at the time of sale.
- Breeder/Seller certifies that both parents have been Health Tested (Hips, Elbows and Patellas) prior to breeding and copies are provided to the Buyer in the Puppy Folder. Any out of the ordinary results were fully disclosed and discussed prior to purchase and every effort has been made to ensure Puppy is healthy, socialized and well raised prior to sale.
- Vaccination, health background and worming details, along with worming tabs to 3 months, are supplied in the Puppy Folder.
- The Puppy Folder includes information on breed management, diet, exercise, grooming and copies of both parents pre-breeding health checks (Hips, Elbows, Patella's).

The Buyer is encouraged to have Puppy examined by a Licensed Veterinarian within 72 hours of purchase, at your own expense.

- **Within 7 Days of Sale** - If the Buyer **changes their mind or circumstances change**, Puppy (including Puppy Folder and Puppy Pack etc.) can be **returned to Breeder/Seller for 50% refund**.

- **Within 14 Days of Sale** - If Puppy is determined to have a **major health defect**, they may be **returned to Breeder/Seller for a Full Refund (100%)**. All items provided at sale (Puppy Folder, Puppy Pack etc.) are also to be returned. This refund policy does NOT cover death due to neglect, abuse or misadventure.

Additional Provisions

- Buyer agrees to provide for Puppy's emotional and physical care, including nutritious food, annual physical examination and vaccinations by a Licensed Veterinarian.
- Buyer agrees to ensure Puppy is registered with their local Council.
- Buyer agrees to house Puppy indoors the majority of time and when outdoors, Puppy will require fixed shade, ample safe and clean water supply and complete and secure fencing.
- Buyer agrees to inform Breeder/Seller if or when Puppy is moved to another city or state/territory and to inform of the new location/contact details.
- Should the Buyer be unwilling or unable to fulfill any of the above provisions, or if any local authority seizes the dog as being neglected or abandoned, the Breeder/Seller retains the right to reclaim Puppy without compensation.
- The Buyer agrees to pay the Breeder/Seller any and all expenses, including court costs and reasonable Attorney fees in enforcing the terms and provisions of the Contract.
